

**City of Cody  
Council Proceedings  
Tuesday, July 20, 2021**

A regular meeting of the Cody City Council was held in the Council Chambers at City Hall in Cody, Wyoming on Tuesday, July 20, 2021 at 7:00 p.m.

Present: Mayor Matt Hall, Council Members, Diane Ballard, Andrew Quick, Heidi Rasmussen, Jerry Fritz, Justin Baily and Emily Swett, City Administrator Barry Cook, City Attorney Scott Kolpitcke, and Administrative Services Officer, Cindy Baker

Absent: None.

Mayor Hall called the meeting to order at 7:00 p.m.

Council Member Baily made a motion seconded by Council Member Ballard to approve the consent calendar as presented including approval of Minutes - Regular Minutes from July 6, 2021 and Special Work Session from July 12, 2021; approve Vouchers and payroll in the amount of \$2,450,034.55; approve the request from Staci Kondelis, Cody High School Football, Park County School District 6 for the street closure of Beck Ave. between 8<sup>th</sup> and 9<sup>th</sup> during the hours of 3:30 PM to 8 PM on Fridays, August 27<sup>th</sup> September 17<sup>th</sup>, September 24<sup>th</sup>, October 8<sup>th</sup>, October 22<sup>nd</sup> October 29<sup>th</sup>, November 5<sup>th</sup> and November 12<sup>th</sup>. The requested closure is for tailgate parties to show support for the football team.; and authorize the Mayor to enter into and sign an agreement between the City of Cody and Park County School District #6 as it relates to the School Resource Officer. Vote was unanimous.
